# **CCA Mentoring Program**

#### Introduction

The program is offered free of charge and available to everyone. The Mentoring Program is specifically designed for new casino chip collectors offering a wealth of information and experience of our seasoned casino chip and memorabilia collectors.

Seasoned collectors have gone through many a trial and tribulation, learning as they go and learning from their mistakes over the years. Knowledge increases little by little over time as we absorb what we can from our interactions with other collectors and individual experiences. If one is going to learn from mistakes, isn't it always best to learn from someone else's mistakes?

Collecting has many forks in its windy road, and is filled with many potential unwise choices, but our experienced collectors will help guide the beginner down the path.

Quite often a new collector just happens to stumble onto a casino chip online message board or web site. They most likely have just a few chips, no price guides and no real idea of the best way to proceed with their new hobby. They often times have no idea how vast chip collecting is. That's where we come in!

- · Find out which price guides are available.
- · Find out which price guides should and shouldn't be used.
- · Be able to ask questions about casino chips and casino related collectibles and find the answers.
- · Find resources online and offline through our resource pages..
- · Find out the best ways to increase your collection.
- · Discover the many different collecting areas of casino memorabilia.
- · Learn from the pros, what's valuable and what's not!

#### The Program

Simply go to www.ccgtcc.com, click on the "EDUCATION" button to the top of the page. From there click on the "CCA Mentoring Program" link and a questionnaire/application will download to your computer, print out and complete the questionnaire/application and mail it to the address provided. The questions are designed to best identify your interests and to match you with a suitable mentor for your particular collecting interests.

Initial Stage: lasts for a period of 30 days. During this time, both parties will be encouraged to communicate back and forth through e-mails, and/or telephone. The mentee (new collector) will be open to ask any and all questions he may be interested in, and the mentor (experienced collector) will address the questions, giving advice and direction.

At the conclusion of the initial 30-day initial stage, the program chairman will contact both parties to see if both wish to continue. If both parties are pleased with how things are going, they may choose to continue for an additional 11 months. This short initial period is particularly good for beginners who just need a little help and direction while getting started.

Either the mentee or the mentor can conclude the relationship at anytime. This may need to be done because of unforeseen real life issues that may arise.

The program will continue for a maximum period of one year from the beginning of the initial active date, with a review after six months.


The Chicago choice marks a quick return to the city as the 2019 event will also be located there.





# 25TH ANNUAL CC&GTCC CONVENTION JUNE 22 - 24, 2017

I his year marks the Club's 25th Annual Convention - an AWESOME LANDMARK of a QUARTER CENTURY of collectors from almost every state and some foreign countries convening to share their interest in - and appreciation for - collecting gaming history!

In the first issue of his newsletter, Archie included a survey, the results of which showed overwhelming support for establishing a formal club and the Casino Chip & Gaming Token Collectors Club, Inc. (the CC&GTCC) became a reality! The Club had its first annual meeting at the American Numismatic Association (ANA) convention in Cincinnati, Ohio in August of 1988. [If you're "doing the math," you will recognize that NEXT year (2018) will be the Club's 30th Anniversary! But, one year at a time! THIS year, we are celebrating our Club's 25th Annual Convention . . . and, we're proud to be a part of it!]







Cullotta was born on December 14, 1938, in Chicago, Illinois. He entered Steinmetz High School in 1953. He began his criminal career as a teenager, graduating from petty theft to burglary, armed robbery, arson, and murder.


Martin Scorsese's 1995 film Casino is based on the lives of Spilotro and Frank "Lefty" Rosenthal as portrayed in Nicholas Pileggi's 1995 book Casino. Cullota—renamed "Frank Marino" in the film and portrayed by actor Frank Vincent—was hired as a technical advisor for the movie. Cullota has also played the role of a hitman who carries out several murders, one of which is similar to the 1979 murder of Sherwin Lisner.

Cullota has written Cullotta: The Life of a Chicago Criminal, Las Vegas Mobster, and Government Witness and has been involved in making several documentaries. He cohosted AMC Mob Month alongside Henry Hill in 2011. and in 2012 he was inducted into the Mob Museum in Las Vegas. Cullotta is known as an underworld historian and an expert on organized crime. In 2013 he told his story in an episode of Banged Up Abroad.

Cullota appeared in the season 5 premiere of Bar Rescue where he gave commentary to the Las Vegas bar

he visits, Champagne's (formerly Champagne's Cafe). He also appeared during the bar's grand re-opening.

# THE 2016 OTY AWARDS CONTEST IS HERE!

That's right! It's time to Nominate!

Inside this issue of the award winning Casino Collectibles News you will find an Official Nomination Form for the 2016 OTY Awards. Every Club member is encouraged to take a little time and reflect back on the fabulous array of chips, tokens strikes and cards issues by casinos worldwide during the calendar year of 2016. If any of them standout in your mind, or take center-place in your collection, then perhaps you might want to recognize them by nominating them as a candidate for the OTY Awards.

Only as a CCA member are you entitled to participate in the Club's annual Chip of the Year (COTY), Token of the Year (TOTY), Silver Strike of the Year (SSOTY) and Slot Card/Room Key of the Year (CKOTY) competitions, aka: The OTY's!

The 2016 Awards will be marking the Club's 28th year of COTY and TOTY competitions, our 18th year of the SSOTY competition and our 16th year for CKOTY honors. I am both honored and pleased to be serving as the COTY, TOTY, SSOTY and CKOTY Awards Competitions Chairman, along with my son, Casey, the Assistant OTY Chairman.

The rules for this year's competitions are pretty much the same as last year, and for our newer members (a very big Welcome to our newcomers) and as a refresher for our seasoned participants, I will go over the requirements once again.

Between April 1, 2017 and April 23, 2017 the Assistant OTY Chairman will be accepting nomi

nations from any and all Club members in good standing. As a reminder to all Regular members, please be sure to make a copy (or copies) of the nomination form for the Associate Member(s) tied to your membership number, so that they too can participate.

Completed, original nomination forms were designed to be folded, taped (stapling is acceptable, but the Post Office prefers tape), affixed with 1st Class postage (.49 cents) and then mailed. Providing that the insert is printed correctly the mailing address will be pre-printed on the reverse of the form. However, completed forms (original forms or copies) may be sent in an envelope to the address that appears of the back of an original form. That address is also re-printed below for your convenience. As we did last year we will accept nominations via email to OTY@CCGTCC.com . However, if you take advantage of this method, you must format your submission into the same headings as the Nomination Form AND you must include all of your nominations at one time. Please do not make piece-meal submissions. If you do, then the most current submission form will replace, in total, any previously submitted form. Emailed submissions must be sent prior to midnight (PST) April 23, 2017.

Judging will be open to any and all CC&GTCC, Inc. members in good standing. The Nominees will all be posted on the Club's website (or linked from there) so that they can be viewed and voted upon by all Club Members, whether or not a member submits a Nomination Form. If you submit a mailed-in Nomination Form, and do not have email, nor access to the internet, a Ballot will be mailed to you. These ballots must be returned via the postal system and must be postmarked on or before a date to-be-determined and announced later. However, voting will also be conducted via email, the details of which will be announced later on the Club's website: www.ccgtcc.com.

For those who are internet connected, you can always visit ChipGuide and perform a search of potential candidates for nomination by using the search utility to find chips, tokens, strikes and room keys/slot cards issued in "2016". Visit the Museum of Gaming History's ChipGuide at: http://themogh.org/cg\_home2.php.

## The fine print:

All nominee candidates must have been issued. for use, for the first time, during the calendar year of 2016. Various members of the CC&GTCC may be called upon to verify the criteria for chips and tokens. The Officers of the Silver Striker's Club shall be called upon to verify the criteria for Silver Strikes. The Officers of the Slot Card and Room Key Club shall be called upon to verify the criteria for slot cards/ room keys.

Chip of the Year eligibility criteria: A chip must be issued by a casino. It must also serve a gaming purpose.

Token of the Year eligibility criteria: A token is one that is intended to be inserted into a slot machine for play. Excluded are coins (money). currency and tickets. The emphasis is on slot machine play. TOTY Awards are currently on hiatus, but will be reestablished if 10 different nominations are made.

Silver Strike of the Year eligibility criteria: Simply stated, an eligible Silver Strike is a bi-metal coin made in follow-on to the Silver Strike Program of IGT. This includes \$300 strikes.

Slot Card/Room Key of the Year eligibility criteria:

> Slot Cards must be issued by a casino and are intended to track player action at a slot machine.

> Room Keys must be issued by an affiliated hotel/casino establishment. The key (looking like a plastic credit card) must be used to open a guest room.

Recently a house in Ft Lee, NJ was put up for auction by Guernsey Auction House. The house is known for a few famous and infamous owners. The house was originally built by Albert Anastasia and his family. After Albert's death in a barber's chair in NYC in 1957, it was then owned by Del Webb, who was part owner of the NY Yankees, for a short time. Then Buddy Hackett became the next owner in 1958. Finally, forty years ago Arthur Imperatore took ownership of the property. Imperatore was long involved in the trucking industry in NJ. Imperatore is now known for owning NY Waterways, the ferry service between Manhattan and several points in New Jersey, across the Hudson River. Yes, the ferry service was an important part of rescuing passengers from the US Air flight that landed in the Hudson River a few years ago. Imperatore's ex-wife recently passed, which is why the house was on the market. Since the house was up for auction, it was open for inspection for a couple days, and I decided to pay a visit.

A little history about the area. Manhattan was relatively open during prohibition. In 1934 Fiòrello La Guardia was elected mayor of NYC.

La Guardia was famous for ferreting out corruption. This included going after racketeers, putting Lucky Luciano in jail and going after Frank Costello's slot machines. So the mob moved their operations over the George Washington Bridge to Ft Lee, NJ. Soon after many members moved to Bergen County to live. The house was just down river from The Riviera Club. The Riviera Club was just north of the George Washington Bridge, opened by Bill Madden, of Cotton Club of Harlem fame, in July 1932. He later sold it to Bill Miller (no relation to me) in 1946. The important part of this story is, the silent partners Meyer Lansky and Albert Anastasia. The Riviera Club was condemned in order to build the lower level of the George Washington Bridge and an exit to the Palisade Interstate Parkway in 1953. Bill Miller moved on to Las Vegas to create floor shows for the Desert Inn and other mob owned casinos.

Albert Anastasia was known as a hit man at an early age. He moved up to become an important leader of Murder Incorporated. Eventually, he became a leading member of the Gambino crime family. Anastasia moved his family to Ft.

Lee in 1944, after being discharged from the Army. In 1947, he moved them into the "L" shaped 6500 sq ft. house, which also had two apartments, that was built on 1.3 acres on Bluff Road. As the street name suggests, the house's patio backs up to 30 to 40 foot drop off down

to Edgewater, NJ. From the rear of the house and patio was the Hudson River with a magnificent view of the Manhattan skyline.



h e house is set far

back from the street to make it difficult to see any activity. The property was gated, with pearoaming cocks around, to act as an alarm system, when the FBI was watching the house. A long driveway passed an elevated pool the area and garages, arriving

at the fountain by the front door.

The mansion was built in the Italianate style, with exterior walls that are eight to ten inches thick. Each room in the house was built with at least two exits, so not to get trapped in a room. The first floor entry foyer, had a curved staircase up to the second floor. The living room ran from the front of the house to the back, with an exit out to the rear patio. A formal dining room was on the other side of the entry foyer. There was two offices / studies, and a breakfast room also on the first floor. There is a large mid-century modern kitchen and pantry, with original tile and cabinets. There is a sunroom that runs along the back of the house, and leads to the patio. The

The second office connects to the two apartments and garages.

The second floor had five bedrooms. and several mid-century modern tile bathrooms. The master bedroom was over the living room and runs the full depth of the house. At the rear of the bedroom is a sun room, where a window looks north toward the bridge, where the Riviera Club could have been seen. The basement had a large game room / bar / theatre. Behind that was the projection room / wine cellar. There are several storage rooms. Rumor has it that there is a secret exit which leads out to Edgewater, NJ.

The house was sold before the auction for \$5.2 million. Most likely the building will be razed. The lot most likely divided into smaller million dollar houses, like what is happening in

most of Bergen County. It is too bad the Fort Lee Historical Society was unable to purchase it for a museum.

# MY BIBLE - THE CHIPGUIDE

## HOW I BECAME A CHIP COLLECTOR

I went to Las Vegas with a large group (about 14 people) back in the late 70s. At that time, to me, chips were just a form of money to be used in the casinos.

My second time at a casino was in Atlantic City when I went with a couple of friends. It was in the early 80s since I went to the Playboy Casino (closed in 1984) and, for some reason, I pocketed a \$1.00 chip. When I got home, I just threw it in a drawer and pretty much forgot about it.

The next time in Atlantic City was a number of years later. I stayed at the Taj Mahal (opened in 1990) where I noticed that there were a number of different

\$5.00 chips in the stack I got at the craps table. That fascinated me so I looked through chips as I got them and saved all the different ones I could find. \$1.00 and \$2.50 chips were all the same but I took one of each of those also. We went to all the other casinos on the Boardwalk where I similarly picked up as many different \$1.00, \$2.50, and \$5.00 chips as I could.

## I WAS ON MY WAY

While walking the Boardwalk, I came across the store run by the late Bob Meara. I was absolutely amazed that:

- Someone could have a store selling casino chips and other stuff related to casinos, and
  - There were people who would buy casino chips

and other stuff related to casinos.

At this point my memory gets a bit hazy but I think Bob Meara turned me onto "Mr. Chips," Archie Black.

I must have emailed him and he told me of his "new issue" service. I quickly signed up for that as the way to keep my chip collection (Atlantic City only at the time) going. I also bought one of his Atlantic City catalogs and some chips that I did not have.

Somewhere along the line, maybe from Archie but I'm not sure, I found out about the ChipGuide, then being run by the late Greg Susong. Two things became obvious to me:

- Collecting would be absolutely impossible without references such as Black's Catalog and the ChipGuide.

A coding system of some sort was a necessity.

From the ChipGuide, I learned what a booming business gaming was, not only in Atlantic City and Nevada but all over the country and, in fact, the world. To keep track of chips, I originally used Archie's coding system for Atlantic City chips and ChipGuide numbers for everything else. By the way, I keep most chips in 2 1/2" flips but a number of them are framed and some are in smaller Jewel Cases. about the size of CD cases. I keep track

of them on spreadsheets, one for each state, and a separate similar spreadsheet of what I'm missing. Also, for those I'm missing, I made up a Word file by cutting/pasting images from the ChipGuide so I have a quick visual reference for what I'm missing, Needless to say, this would be impossible without

my BIBLE, the ChipGuide.

## **GATHERING CHIPS**

I do a fair amount of business travel and, as a chip collector does, whenever I am near (very subjective term at times meaning several hundred miles) casinos, I make it a point to spend an extra day or two or more visiting as many casinos as I can.

Using the ChipGuide as my BIBLE, I plan trips around my business travel. As an example, years ago I had a meeting in Detroit after which I went from Detroit up to the Mackinac Straits visiting every casino at the time in the Lower Peninsula, then into the Upper Peninsula, again visiting every casino

there, and then into Wisconsin and Minnesota. I couldn't get to every casino in those states but I did what I could. Thinking back, I spent three nights out and put close to 2000 miles on the rental car.



I do similar trips in the west. As examples, after a meeting in Phoenix, I would visit as many casinos as I could in Arizona and New Mexico; and after meetings in San Diego and San Francisco, I would visit as many casinos as I could in California.

I live in Massachusetts and, for several reasons, I am able to regularly, every year or two, visit casinos as far west as eastern lowa and as far south as West

Virginia.

At some point, I discovered that there were people in other parts of the country who offered new issue

services similar to what Archie had in Atlantic City. This enabled me to keep up with new issues, and get some older chips, from many parts of the country. Unfortunately, many of these are no longer active or are of little interest to me.

Further, and very importantly, over the years I have established relationships with a number of collectors across the country for buying/selling/trading chips.



#### THE PROBLEM

I started as a total generalist, gathering chips from all over the country, some wet chips, and some foreign chips. Maybe ten years ago, I realized that I could

> no longer be a total generalist. I'm sure many other collectors along the way came to this realization.

One of the catalysts in coming to that realization is a very sad gathering story. I started in Dallas and spent three days driving all over Oklahoma gathering chips, ending up in Kansas City where I also gathered a number of chips. I accumulated at least \$300.00 to \$400.00 worth (face value) with the help of many

very cooperative casino personnel. As an example of cooperative personnel, I don't remember what casino it was but I was there maybe an hour before their poker room was going to open. The room manager and cashier went through dozens of racks of chips looking for what I wanted. They found all the chips

Il was looking for and of course I tipped the cashier generously.

The sad part is that I packed the chips in a suitcase that I checked in Kansas City for the trip back to Dallas. The suitcase disappeared along with all the chips! At that point, I decided that I would never be able to gather those chips again so I gave up on Oklahoma.

I then realized I could not keep up with chips in a number of states such as Wisconsin, Minnesota, North Dakota, and South Dakota. Similarly, while I do collect from the Indian casinos in California, Oregon, Washington, and Montana, I gave up on the card rooms in those states. Finally, I gave up on the three mining towns in Colorado but I have continued with the Indian casinos in the southwest part of that state.

For pretty much the same reasons, I have given up on wet chips and foreign chips. But, on the other hand, I've gone up to all chips below \$25.00 including odd face amounts such as \$7.00, \$7.50, \$8.00, \$10.00, and \$20.00.

## **CURRENT STATUS**

I implied earlier that, without my **BIBLE**, the ChipGuide, I would be lost in the hobby. Had I not been told about the ChipGuide, I may very well have given up collecting early since, other than for Atlantic City and Archie Black, I would not have had any way of knowing what's out there. Because of the ChipGuide, I have a coding system for my chips and a reference source to know what chips I'm missing.

Usually, since I know the casinos I'll be visiting on a trip, I will scan my collection or cut/paste images from the ChipGuide of what I have or what I need. The latter has impressed many casino personnel (pit bosses, dealers, cashiers) since they often did not know there are a significant number of chip collectors out here and, if they knew, they had no idea we are organized. Many have asked how I got the images and I then explain the CC&GTCC and the ChipGuide.

## NOW THE RUB

I have submitted about 150 chips to the ChipGuide and there are a number of collectors who have submitted more than that. Actually, my number is greater because, in some instances, I ask that my name not be published.

Unfortunately some collectors who discover new chips don't submit them. I have seen images on the Chipboard of new chips that have not been posted on the ChipGuide. When I get these chips, I do submit them but I really wonder why the people who posted

them on the Chipboard did not submit them to the ChipGuide.

A recent personal story in that vein is that I found a grand opening chip at a casino which I had no reason to stop at other than it being lunch time since, as far as I knew from the ChipGuide, I had all the chips I wanted from there. At that casino, when I heard from a pit boss that there had been a grand opening chip a couple of years earlier, I went to the poker room cage to get one. I paid \$500.00 for a rack of \$5.00 chips and, after going through that rack, traded it for another one. After doing this several times, the cashier took pity on me and made a call to the main cage. I was told to ask for Jane Doe (I don't remember her actual name) and she sold me three uncirculated ones from the vault. I tipped the cashiers and went back to the poker room cashier and tipped him also. I sold the extra two but someone I spoke to shortly thereafter said that he already had the chip. I asked why he had not submitted it to the ChipGuide and, as I recall, got a rather lame answer.

## SUBMITTING CHIPS

To me, submitting chips is part of being a collector. Somewhat selfishly, by submitting chips and having ChipGuide numbers assigned to them, I have a way to catalog chips and to refer to them when needed.

Scanning is easy. All you need is a scanner attached to your computer. To make editing scans easier, there is a free program called PhotoScape which can be used to edit scanned images. It is extremely flexible, is very useful for chips because it has a "CROP ROUND" feature, and I find it fun to use.

On the Submission Page of the ChipGuide, there is a line headed "Resources for Submitters" with two links: "Casino Chip Scanning Tips" and "PhotoScape Download". As implied, the latter will allow you to download PhotoScape and the former has instructions on how to use it for submissions to the ChipGuide. Once you have this program, you will find other personal uses for it.

To me, discovering new chips, scanning them, PhotoScaping (new verb!) them, and submitting them to the ChipGuide is an important part of being a CCGTCC member. Not a big deal to me whether or not I get credit for the submission. In fact, when I get a chip by trading, I usually ask that my name not be published since I did not discover it. When that happens, I tell the person I got the chip from that I am submitting the chip but not taking credit for it.

## FINALE

I'm inclined to think that my story about how I got into collecting and how my interests expanded and then contracted is not unfamiliar to many collectors. I have to believe that most collectors got into this hobby by accident, found it interesting, started collecting everything, realized that collecting everything was impossible, and then picked their areas of interest.

I mentioned the ChipGuide many times and the fact that I use it as my collecting BIBLE. I urge everyone who reads this to submit chips not currently included on the ChipGuide. By doing that, our hobby will continue to grow and prosper. Also, if you find any errors on the ChipGuide, contact Albert Scalzo (albert@themogh.org) or Charles Kaplan (ChipGuide@themogh.org). They are extremely cooperative relative to fixing things on the ChipGuide. The ChipGuide is a true Labor of Love for them.

# **Mounds Club**

32200 Chardon Rd. Willoughby Hills, Ohio

Thomas "Black Jack" McGinty a well known Cleveland gambler, best featherweight boxer of 1912, and later

boxing promoter had opened a gambling joint at 2077 West 25th St. in Cleveland, OH around 1926. It was known as McGinty's Joint, or the Mounds Club during its 10 year operation. Eliot Ness and his raiders raided the third floor, well secured operation in July 1936. This location would close, but the "other" Mounds Club would keep on running.

The larger and more lavish Mounds Club built by McGinty on the east side of Cleveland opened in 1930. McGinty was associated with the Cleveland Gang along with other members, Moe Dalitz and Morris Kleinman, who were reputed to be silent partners in the Mounds Club. An upscale place, the Mounds featured some of the best entertainment in the area. hosting performers such as Sophie Tucker, Helen Morgan and Lena Horne and comedians

like Joe E. Lewis. The club's dining room held 200 guests who were served on china plates, edged in gold and maroon and a gold lion, the club's symbol. The Mounds offered high-stakes poker, blackjack, dice and roulette. Two concrete lions guarded the main entrance to the white-framed building along with some well-armed guards. The club would shut down in late fall when the high rollers and the horses went to Florida and then reopened in mid-May when these gamblers returned to Ohio. William Swartz was formally the manager of the club in May 1936.

Early on September 23, 1947 ten men burst into the club firing shots into the ceiling. They had bypassed an electrified fence, overwhelmed the club's security forces and then proceeded to casually rob the club and about 300 patrons of cash and jewelry totaling \$450,000. A short time later a casino in Chesapeake, Ohio (probably the Colony or Continental) was

robbed of \$60,000 by six men in a similar fashion.

In the case of the Mounds, police were baffled as to how to report a robbery of a place they had to admit didn't exist. Within two weeks the robbers' hideout was discovered in a summer cottage at Luna Pier between Toledo and Detroit. Reports that Mounds Club moneybags and two Thompson sub-machine guns stolen from the Collinwood armory of the Michigan State Police were discovered in the hideout. Federal agents in Cleveland later reported that through the grapevine they understood the syndicate leaders conducted their own investigation and those responsible had been "eliminated." Police received information that the robbery may have been linked to the Detroit Purple Gang. No one was ever charged in the robbery and the case is still open.

Between 1930 and 1948 the club was the target of many raids by Lake County officials and State of Ohio law enforcement. The club always managed to stay

in business and one step ahead of the raiders. In early 1949, Governor Lausche vowed to close the club. In July 1949 the club was raided and arrested were club manager Thomas Farley and bartender Ray Rehart for possession of illegal liquor. State



liquor officials obtained a court order to close down and padlock the Mounds Club. In addition, the state fire marshal and building inspectors ordered the club closed for safety violations.

Other partners were Cornelius Jones and at one time M.W. Schaffner who was said to have a 20% stake. One time manager William B. Swartz was also an owner along with his brother, Howard, of the Colony Club in Chesapeake, Ohio. McGinty was a co-owner of the Desert Inn Las Vegas and a partner with

Charles "Chuck" Polizzi in the Beverly Hills Country Club in Kentucky. Their profits would be better used in the next venture - the Las Vergas Desert Inn. In 1951, after testifying at the Keyfauver Crime Commission hearings, McGinty avoided federal prosecution and soon retired to West Palm Beach. Florida where he died in 1970. John E. Creadon, age 48, a former part owner of the Mounds was found dead in his hotel room.

McGinty saw the future and he and his Cleveland Gang associates sold most of their interests in 1950 to Mr. and Mrs. Lawrence Guardio of Beachwood, Ohio and Frank Chapel of Euclid, Ohio. In September 1952 the Mounds Club appeared ready to reopen. The grounds continued to be well kept and there was a watchman on duty. During the three years after being closed, over \$35,000 had been spent on remodeling and violation corrections. Just two days after Christmas in 1956 an explosion rocked the Mounds Club. The building was planned to reopen as a recreation spot for the General Sewer and Water Contractors Association of Cleveland.

In 2013 the site of the old Mounds Club became the La-Vera Party Center and looks much the same as the Mounds Club did over 50 years ago. Tony Verdone, nephew of Larry Guardio, who purchased the club from McGinty, is the third generation of the family that had operated the club. The name La-Vera comes from Larry and Vera Guardio.

# Building Las Vegas

Winston Churchill once said, "We shape our buildings; thereafter they shape us." Viewed in that light, casino/hotel buildings are the products of their time, which then turn around and influence those who play and stay in them for years to come.

One of the recurring themes in casino chip design is a depiction of the building that houses the hotel and casino operations. This is particularly true of properties from the so-called "mega-resort" era. The building itself is a major part of the attraction and the marketing of the property carries through to the face of the casino chips.

In the early days of Las Vegas, casinos were mostly small clubs, just large enough to house a few gaming tables and some slot machines. Over the years the buildings got bigger, taller and fancier - culminating in mega themed resorts with casinos bigger than 100,000 square feet and hotels that contain thousands of rooms.

Pictured alphabetically below (left to right, top to bottom) are 30 examples of famous Las Vegas casino/hotels depicted on chip inlays:



Caesars Palace appears as it looked on opening day in August 1966... the Carver House was located on E. Fremont Street from 1961 to 1965... the Desert Inn was open on the Strip from 1950 until 2000... the El Cortez downtown was once co-owned by Bugsy Siegel... El Rancho Vegas was the first casino resort on the Strip; it burned to the ground in June 1960.



The Horseshoe was built by Benny Binion and first opened its doors in 1951... the distinctive Landmark tower was open from 1969 to 1990. The medieval-themed Excalibur opened in June 1990... the Fremont is located at 200 Fremont Street downtown... the Golden Gate is housed in one of the earliest buildings constructed in downtown Las Vegas.



The Las Vegas Hilton has had several names over the years (International, Hilton, LVH, Westgate)... the Luxor shows off its distinctive pyramid design... Mandalay Bay opened on the south Strip in 1999... the Mint was located downtown from 1957 until it was absorbed by the Horseshoe in 1988... the Mirage was the first super-resort on the Strip opening in 1989.



The Monte Carlo is located just north of NYNY on the Strip... the New Frontier opened as the Last Frontier in 1942 and closed in 2007... New York New York features replicas of several famous NY City landmarks... Palace Station began as The Casino, then became Bingo Palace, and finally Palace Station... Sheldon Adelson opened the Palazzo in December 2007.



The Pioneer Club opened on Fremont Street in 1942 - "Vegas Vic" was added in 1951... the Plaza was built on the site of the old Union Pacific train station in 1971... the Sahara anchored the north end of the Strip from 1952 to 2011... the Sands (A Place In The Sun) was built by Jake Freedman in 1952... the Stardust was a Strip fixture from 1958 until 2006.



Bob Stupak opened the Stratosphere in 1996 on the site of his old Vegas World casino... Treasure Island was built as a companion property to the Mirage in 1993... the Tropicana has occupied the south Strip since 1957... Sheldon Adelson's Venetian opened in May 1999 on the site of the Sands... Westgate is current name of the property that was the Las Vegas Hilton.

# **Gulf Explorer & The Casino Royale**

Ken Morgan is one of those individuals in life who seems forever to be tilting at windmills, much in the Don Quixote fashion. These days, he is actively involved in trying to get cannabis legalized in New Zealand. But in 1986, he was trying to get casino gambling legalized. At the time, the Totalisator Agency Board (TAB), was the only legalized form of gambling (lotteries, sport books, and similar related gambling).

Morgan had earlier successfully changed the country's Saturday trading laws, so he was not one to let the status quo stay as it was, especially if there was to be a profit in it for him! When he was derailed in an attempt to set up a landbased casino, he looked to off shore games as a viable alternative.

As such, he purchased the Gulf Explorer, and spent some \$6,000,000 refitting it as a floating casino2. The ship started life in 1964 as the Queen of the Isles, before being sold in 1970 and renamed Olovaha before being purchased and renamed once again3. Not allowed to depart from Auckland wharves, he settled on Marsden Point, located near Whangarel, some 139 kilometers north. It was here, its new life started with its maiden voyage headed for the 3-mile limit.

Later, the boat sailed from Tauranga as a variety or problems followed the ship. Finally, a writ was issued by the New Zealand High Court and on 3 August 1986, the vessel was arrested with several large debts, bringing the boat, the casino, his company, as well as his dream to an end. Eventually however, landbased gaming was legalized, so in the end, while he was not an owner of a casino, he did, in some small way, help usher in expanded gambling.

As with any such endeavor, there are relics to be had. The problem, of course, is to find them. Cruise ships and day cruises are always difficult, as opposed to land based casinos. They are somewhat more difficult to get to, and a tad bit more expensive to enter. Not counting the cost of getting to (and back again) from the location in question, the cost of going on the cruise itself is in addition to the cost of anything that you might decide to pick up and keep!

Keen eyed Matt Elliott found an auction site (trademe.co.nz) were a number of chips from this ship were being offered for sale. Made by John Huxley Casino Equipment, chips were Gold Hot Stamp, 8 Suit pips, with no inserts, as follows:

# MYSTERY CHIP

In 1990 the Colorado voters passed into law the legalization of casino gaming in three Colorado mountain towns. Central City was one of the towns and the first licensed casino in Colorado was Baby Does which opened October 1, 1991 and closed January 1, 1995. It is interesting to note that of the initial Central City casinos opened, 11 in 1991 and 17 in 1992, very few survived more than a couple of years. In fact, there are only 2 casinos of the original 28 still open. The Toll Gate casino opened on July 4, 1992 and then closed on July 11, 1993.

While inventorying and cataloging my Colorado chip collections, I came upon a chip that was not listed in either the Complete Guide to Colorado Chips, Tokens and Silver Strikes, 13th Edition June 2014 by Allen Banick or the Colorado Casino Chip Guide, First Edition 2009 by David Niver. Wow I thought, Bonanza, One of a kind I thought as I wondered what to do next.

The mystery chip in question is a five dollar chip, pink in color, horse head right (HHR) mold, and three light blue inserts from the Toll Gate Casino which was located in Central City, Colorado. Both of the chip guides list or picture one five dollar chip for the Toll Gate Casino as red in color, horse head or horse head right mold, with three blue inserts.

The Casino Chip and Token News Magazine of the Casino Chip and Gaming Token Collectors Club had an article in the spring 2005 issue labeled 'Tips for Researching Unidentified Chips'. This article helped me get started. Among other items, it mentioned networking with other collectors, utilizing the internet,

checking manufacturer's records and as I have already done, using printed chip guides.

Another valuable resource is The Chip Guide of the Museum of Gaming History Web Site. I searched under Colorado, Toll Gate Casino, and found the attached Casino Report by Janice O'Neal. See opposite page.

Among other items of interest and reference, this report clearly shows only one five dollar chip which is in agreement with all of the information listed above. I don't know why the information is crossed out but all of her casino reports in the Chip Guide seem to be crossed out.

The Colorado Casino Collectibles Club was established in 1992 and because there are still some active members today from the original club, I am hoping to get more information on the Mystery Chip from them.

I first emailed Eric Miller who is the Colorado Club's Newsletter editor. I attached the scan to see what he knows if anything about the Mystery Chip. His response was, "I would say it is faded from sun exposure". That was one of my original thoughts, but thinking about this, wouldn't the colors be blotchy and uneven unless someone kept turning the chip over and over? I then sent him another scan of both chips showing the reverse or back side which indicates the both sides and the rim are the same color with no deviation. He did not respond after receiving the new scan.

Next I sent emails to David Niver, Ken Hallenbeck and Allen Banick including the scans and Eric Miller's response. David's response was, "I think the chip has been cleaned. The picture shows some weakness in the printing". Ken commented, "My opinion is that it may have been out in the sun for an extended period of time and gotten bleached. It's interesting that both sides are this way, so I could be very wrong. Perhaps someone did this deliberately. Who knows?" Allen wrote back with, "I've never seen one quite like this. Being more pink than red, it would not be a legal \$5 chip in Colorado." Eric's theory is interesting

and while I've seen Chipcos fade a lot, I've never seen a Paulson with that much color change."

Following up on Allen's comment regarding the legality of the chip, I contacted the Department of Revenue, Enforcement Division - Gaming to see what the rules are in regards to the colors of chips. This is what they had, "The two dollar and fifty cent chip must be predominantly pink' and 'The five dollar chip must be predominantly red." While I was there, I also asked if there were any records available which would indicate the chips that were approved for use in the casinos. Their answer was that initially in the early stages of casino gaming, record keeping was not very good and they could not locate any of the earlier records. Now each casino must submit their chip information before the license is approved.

Based on the above information and still not having anything definitive on the Mystery Chip, I sent emails to five more original club members and attached all of the above information. I only received one response and that was from Clyde Massaro who incidentally was the first President of the Colorado Casino Collectibles Club. He wrote, "Now to give my best guess from 25 years of collecting casino chips. When waitresses bring drinks, some patrons give them a tip. When the chip given as a tip is placed on the wet cork tray that usually has spilled alcohol which will fade the color of clay chips like Paulsen's. You can test this theory if you have some extra chips and some hard liquor, then report back to us. The chip will fade, and if you leave the chip in liquid for a long enough period of time,

it will dissolve. Hope this helps, Clyde". This is an interesting theory. While I had the hard liquor I do not have some extra chips of the Horse Head Right mold.

From 1965 to 1994, the Horse Head Right (HHR) mold was produced by Langworthy & Co., Las Vegas NV. I spoke with Kevin Jarchow who is the son of the original owner and he did not have any shipping records to confirm or deny the existence of the Mystery Chip. He did say that the Langworthy Company was sold in 1994 to Wico Gaming Supply, Las Vegas NV. This

company went bankrupt in 1996 and then was under the ownership of Gambler's General Store, Las Vegas NV. and Atlantic Standard Molding, Portland ME. Classic Poker Chips Company took over from Atlantic Standard Molding in 2013-2014 and the Horse Head Right (HHR) mold is still being produced in Maine.

I spoke with David Spragg who is with Classic Poker Chips and after explaining what I was calling about, he asked me to send him the scans of the Toll Gate casino chips. His initial response after receiving the scans was: "We've been through records as best as possible. There was only one order supplied to Toll

Gate so it would not have been possible that the pink chip was supplied in the color it is now. We agree that sunlight would not have affected the chip evenly on both in Eurie + Verner. sides (and would also have yellowed the inlay), but it is noted that there is also a small amount of fading in the print and that the blue inserts have faded to a color which never existed. The only explanation the old timers can give was that the chip was either exposed to something like steam or momentarily dropped into some liquid which slightly "bleached" the chip."

I then sent him a copy of Clyde Massaro's response. His comments were, "We didn't have pink clay back then. Our color is only 3 years old. I don't buy that theory at all. Alcohol is basically ether and water. The ether evaporates and the water does nothing to the chip at all. Liquor would never dissolve a chip if left for 50 years. It might clean the dirt off though."

I thanked him for all of his help and mentioned that I would just list this chip in my collection as an illegal or counterfeit. I offered to send the chip to him so he could see the actual colors. He responded: "I can tell well enough by comparison to the good example you scanned next to it. I would merely describe it as 'Color Affected', it's not an illegal or counterfeit."

Well there it is. In my many years of "chipping", I have never heard the term 'Color Affected' and who would have even thought about it. Anyway, to put this subject to bed, I have no idea when or where I picked up this chip. In the last 15

years or so, I have attended many annual CC&GTCC conventions and many trading sessions. I would hope that the color change on this Mystery Chip was accidental and not with the intent to defraud or confuse fellow chip collectors.

I again went to The Chip Guide of the Museum of Gaming History Web Site. I searched under Colorado, Baby Does Casino, and found the attached Casino Report by Janice O'Neal. See opposite page.

While this is the same type of report as the Toll Gate Casino, this report does indicate a pink color five dollar chip along with a red color five dollar chip. Now without knowing how she obtained the chip details, did she actually see the pink chip or was the information given to her?





# Where Chip Collecting Meets Playable Sets

I had just settled into a \$2/\$4 poker table at the South Point last year when I happened to notice the fellow sitting next to me was using his personal chip as a card protector. I asked if he was there for the convention and told him it was my first year attending. Apparently it was his first year attending as a vendor, so we got to talking about collections, expectations, and the like. I

told him that my primary interest was collecting and using playable sets, at which point he cocked his head to the side like a dog would when you're telling them something they clearly don't understand. Then I showed him a picture of my set of 800 2nd Edition Tropicana Las Vegas chips and his jaw dropped.

I had clearly just introduced him to something he wasn't familiar with, and I quickly got the sense that I was in for

a vendor hall experience that would be culture shock to me. After all, I'm used to dealing in quantities of 100 or more of the same chip, or 400+ chips when trading sets. When I walked into the vendor hall the next morning, my suspicion was confirmed- I was in a different world. Quantities were different. Pricing was different. The entire collecting focus was different. Folks at the convention were frequently looking for very old, scarce chips; I lost count of the times I heard someone say, "Let me show you something you've never seen before!" proud as a fisherman showing off his prized lunker.

My hopes of finding chips in playable quantities were ultimately dashed. I still found plenty of treasures, of course, and had a great time- I ultimately joined the CCGT&CC by way of Jerry Vergatos while I was there- but as much as my eyes were opened wide to the world of individual chip collecting, I couldn't help but feel like there was a call to expose the club a little more to the

world of building sets. I'm not referring to purchasing a custom set, necessarily, although task the designing, iterating, and ultimately receiving your own custom set is worthwhile and fulfilling in its own right. Rather. I'm talking about piecing together a playable set of chips from casi-

nos. Over the next year or so I'll be discussing the thought processes that go into building a playable set. But before we go into the how's, it might be helpful to start with the why's...

So, why build a set?

The reason I first started looking to buy a set a few years ago was because I wanted to start hosting poker games again like my father did decades before. My father, his friends, and their sons would all get together and play poker one Friday a month. It was just a penny

game with a three cent maximum bet and three raises per street, and it was really more about the camaraderie than the cards, but I loved it. And that's a great reason to build a set- to play games with the items the professionals use. Most chips made for home chips, whether they're the ubiquitous dice chips, China clays, or other slugged/injection-molded chips, are of lower quality, and none have the same sound or feel of the heavy T.R. King or Paulson chips of old. And playing with the real thing comes with a certain psychological currency of its own- it always feels better to play with the game ball or wear an authentic jersey than it does to use the practice equipment.

Another reason to start putting together a set of chips is the joy that comes with the hunt. My

first set of chips with genuine shaped inlays was from the primary rack of the Empress in Joliet, Illinois. The trouble with that is I only received a single rack of \$1 chips in my initial purchase, and to make it playable I was going to need another full rack (we'll discuss exactly what makes up a playable set in future articles). At that point I took to eBay, The Chip Board, Poker Chip Forum, and any other outlet I could find to source the chips I needed. One by one, the rack started to come together- I thought I was in heaven when I sourced 20 at one time!- until it was finally completed. And then, moments after I finished it and barely over the joy of completing that rack, I started putting together the next rack like a fiend. It's not about the destination when it comes to putting some sets and racks together, but rather the challenge of the journey itself.

But the best reason of all to use a quality set of casino chips is because, frankly, they were made to be used. Part of preserving the history of gaming is certainly obtaining, protecting, displaying, and sharing relevant relics of gambling; the club,

the museum, and we as club members have all done a fantastic job of doing that up to now. By my observations, though, the one thing missing from the task of preserving that history is putting those relics to work, and doing so openly and with frequency. What better way to honor the spirit of the chips, tables, ash trays, glasses, swizzle sticks, and the like, than to actually use them for what they were intended for? By no means am I suggesting that we put those scarce and rare chips or museum-quality pieces into use, but there's plenty of bulk chips out there that could be put into playable quantities and used for their original intended purpose.

My goal over the next year is to see more members and vendors start thinking about their bulk chips a little bit more in terms of how they could be used with or sold in quantity for sets, and to share the joy found in not just sourcing the chips for a set, but using them over a game of poker with friends. Hopefully you'll follow along, and by next year you'll be hosting a game of your own using a set you just finished from Vegas, Atlantic City, the Gulf region, or whatever gaming region you call home. Until next time, I'll see you at the tables!

# An Introduction to Casino and **Poker Card Guards or Protectors**

This article is an introduction to casino and poker card quards, or protectors. In card games, where all of a player's cards are facedown, a player may use an item like a specialty chip or figure, to place on top of their cards to protect them from being accidentally discarded by the dealer during play. It is <u>not</u> until your pocket cards (Texas Hold'em) have mistakenly been 'mucked', that you realize the importance of a card quard, also known as card protector, cap, capper or cover.

## Why Use a Card Guard or Protector

In order to guard or protect the two cards dealt to each player, known as 'Hole Cards', many players like to cover their cards with something weighted, to ensure that they are not inadvertently 'mucked' by the dealer or another player. I learned my lesson the hard way. While I was playing in a big tournament at the Bellagio, I was sitting immediately to the left of the dealer in seat 1. I had my Hole Cards accidentally 'mucked' by the dealer, in a hand that would have seen me go onto win a massive. Guards may also be used to cover stacks of tournament chips. Ed. note, I had my cards mucked at the final table at our tournament possibly changing my finishing place.

## World Series of Poker Card Guard Rules

#### Rule #41

All participants must keep their cards visible at all times. Participants are encouraged to use a card cap, rather than their hands, to protect their cards. This the cards will be easily seen. Participants may at no time hide their cards or disguise them in any way.

Foreign Objects: There will be no foreign objects

on the table except for a maximum of one card cap (also known as a card protector). Card caps can be no larger than two (2) inches in diameter and no more than one-half (1/2) inch in depth. Participants may not place any food or beverages on the poker table with the exception of one (1) capped bottle of water.

Where the World Series of Poker (WSOP) has specifically stated rules, most poker rooms do not. I have played and spoken to various Poker Room Mangers over the years, not to find any set rules for their tournaments. Needless to say over the years I have seen a variety of guards of different chips, shapes, sizes, colours, items, and weights on the felt.

## The Difference Between a Card Guard and a Spinner

Players use a variety of tems for card guards such as, lucky charms, small photo frames containing a family picture, cartoon characters, plastic animals, Soccer Coins (used for coin toss), and many other small trinkets. I have referred to 'Officially' issued card guards, as those that are provided by a casino, poker tournament sponsor, leagues, club, or charity. These guards are specifically made to promote their poker tournaments, or cause. Remember the two primary reasons for a quard: first to protect your hole cards, second for advertising purposes. Since poker tournaments first televised in the late 70's, sponsors have realized the importance of the card guards in promoting their product or service.

There is an interesting story behind a set of four 'Diamond' shaped card guards, that were issued by The Victoria Casino (The Vic), London. When The Vic had contracted to undertake their first televised tournament, they were hoping to use circular card guards. It was soon brought to their attention by the television production crew, that TV viewers may mistake the circular shaped card guards for the player's tournament chips. To ensure that there would be no confusion, the diamond shape concept was born, for the one and only time to date.



A spinner is a unique type of card protector. A spinner is placed on your cards like a guard by a player during a poker game. On the reverse side of a spinner there is a very small, rounded pivot or ball bearing. This allows the spinner to move in a circular motion without damaging cards, table tops, or other items. They can rotate either clockwise or counter-clockwise. So like a quard, they protect your hand from being mucked accidentally by a dealer. Some spinners are designed to tell you your next move: hold, fold, raise, etc. Players find spinners useful if you go 'card-dead', as you can just spin away, while seated, until your 'hole' cards improve and you can start getting involved in the game once again. Other players prefer these spinners to a regular card protector to spin their tensions away ... while aggravating the other players at the same time! Many of the Hard Rock poker rooms give out one of their spinners to the winner of the 'High Hand of the Hour' or for hitting a Royal Flush.







The annual Royal Poker Tour which is held on board a Royal Caribbean Cruise ship, have produced a different spinner for most of their tournaments.





I think the most ornate spinner that I have, is one produced by Princess Cruises' poker tournament.



Spinners started appearing on the poker tables in abundance in the late '90. I have known several poker rooms ban the use of spinners. If a player presses down hard on a spinner and rotates it, a mark maybe left on the playing card.

## Manufacture Of Card Guards

Casino and poker sponsor budgets have been shaved over the years along with cost of inflation, thereby having a toll on the availability of card guards. It has become very noticeable, that card quards manufactured pre 2009, were made in a superior quality and weight, than the bulk of those currently being issued by the same poker rooms, sponsors, and clubs. By comparing the weight of card guards manufactured between the mid 80's and 2005, it is very noticeable that some casinos and poker sponsors have had to reduce the weight of their card quards. It is no accident that some card guards have a logo on the face side only, with a

blank reverse, thus reducing the unit cost of guards. There are many casinos and poker operators that no longer produce card guards, due to rising costs.

In the late 80's and 90's the majority of card quards were sourced from the Far East, as the manufacturing costs were lower than those of manufacturers in the U.S. and Europe. In addition, China has an ancient technique known as Cloisonné, as well as, epola or a hard enamel resin, which is a fake Cloisonné. These processes lend itself to the design, weight and manufacture of some of the most superior card guards decorated metalwork with enamel inlays. Many of the better quards in my collection are manufactured using these processes. Unfortunately, the Cloisonné manufacturing process is now in limited use, due to the high production costs involved. The original method of die stamping brass, has been largely superseded by zinc alloy castings, especially in the promotional market. This is where the card quard is ordered by a company and used as "a giveaway" or prize. Although, stamped iron is still used quite extensively for mass production in the retail market, where you would buy from a shop or online, not secondhand.



An easy test to see if the card guard has an iron base is to use a magnet. However, this will not help in differentiating between a brass or a zinc alloy base. The following is an example of the manufacturing process used.

Artwork is supplied to the manufacturer. While Adobe Illustrator is an editable format, the preferred format is a PDF file.

Design studio at the factory may amend your artwork, so that it is suitable for the production process. **Tooling** once the artwork has been approved by the client, the factory will then produce the tooling. This usually requires a stainless steel mold. If the delivery time schedule allows, this will enable the factory to produce a preproduction sample. If not, then the factory goes straight into mass production.

Production of the raw card guard in either brass, copper, iron, or a zinc alloy material. The metal used for the production process will depend upon a number of factors; quality desired, budget of client, or the design and size. Designs can be two dimensional (width and height), or three dimensional (which includes contours.) The raw guard is subject to the clients requirements and the way the factory designer interprets the artwork.

Coloring soft enamel (standard paint), or imitated hard enamel (polished enamel), are subject to the Pantone color guide for the choice of color to be applied to the product. The coloring process is applied by syringe. One color at a time is applied onto the product. The application of a translucent resin coating (epoxy) onto soft enamel will give a shinny effect and protect the final product. Alternative design effects can be, screen printing, offset printing, or, CYMK enamel color, a direct printing of enamel with less pixel look then other standard printing processes.


**Plating** all products are plated as per the customer's preferred metal finish. While the most common metal plating finishes are nickel silver, and gold, but not limited to these. Guards can have different effects added, which include, standard, shiny, antique finish, matt, or a misty finish.

**Polishing** a hand polish will be applied to the products surface to achieve a better shine and smooth finish. The amount of shine is subject to the material base usage. Brass will be more shiny, while iron will give a more rough looking finish.

Oven drying an enamel color or plating, is heated to a temperature from 30 degree Celsius to a high of 90 degrees, and subject to color contrast for 30 to 60 minutes. A longer time is required for hard enamel finishes.

Cleansing and Quality Control the individual pieces will then be cleaned and inspected being before packed. This is to ensure that the design, color, weight, and other aspects, adhere to the client's specifications.

The U.S. now, has numerous coin and medal manufacturers, who can offer a much quicker delivery 'turn-around' than that of their Chinese counter parts. They also can compete on price with the Asia manufacturers. 'Coin' card guards are normally smaller in size and lighter in weight, than the enamelled variety, but they are a very clean and well produced product.



I have seen a steady growth in the number of card quards manufactured in .999 Silver since the early 2000's. Due to the high cost per unit, these are generally issued to players in a high value buy-in tournaments and / or the final table players.

## How Did I Start Collecting

2007 - I went to the Rio in Las Vegas in June 2007, for the first time, to play in a WSOP side event. While I familiarised myself with the various poker rooms, I noticed that there was room selling various branded WSOP items. The assortment available included discounted 2006 card guards and dealer buttons and the current 2007 card guards. As a memento for attending my first WSOP, I bought one of each of the different card guards and placed them in drawer when I got back home.









2008 - Fast forward to my next visit to the Rio to play in the 2008 WSOP side event. I bought various 2008 card quards. My appetite for card quards was now in its infinite stage. I then played in a Venetian Deepstack Tournament and earned enough Player Points with my entrance fee to obtain either a cap, t-shirt or card guard. Yes you guessed, I took the Deepstack card.

Two days after playing in the Deepstack tournament, I played in a tournament at the Bellagio. After I had been knocked out of the Bellagio tournament, I decided that I would obtain a card guard. This was to ensure that I would never again have my hole cards mucked accidentally. I bought a small silver skull figurine and used it in the next tournament that I participated in. Unfortunately, it kept on falling over, which always got a laugh. So I went out to a jewellery store to purchased a circular base. I then asked the jeweller to solder the skull figurine onto the circular base. Next, I asked the jeweller to engrave on the base "Skullman." I used this card guard in every tournament that I played in for the following six months, but I was still unhappy with the weight and size of it!



September 2008 - I was participating in a poker tournament at The Grosvenor Casino Liverpool, known as The Leo Casino, where all participants were given a particularly nice, THE GREAT BRITISH POKER TOUR card guard. Remembering the WSOP card guards that I already had, I decided that I would start collecting card guards. I started making inquiries of all my poker chums, as to what they had got tucked away in their drawers and cupboards. While, I knew there were many Chippers out there, I did not come across anyone else collecting card quards. Being that no one appeared to be collecting them, I found that at each tournament that I attended, that players would just bring them in for me.



December 2008 - I had taken it upon myself to find a company that could make a bespoke card (custom card) for me. I had remembered seeing various stores in Vegas selling exceptionally well made, and designed skull jewellery, by Room 101. Room 101 was located in Los Angeles. I contacted Mr. Matt Booth CEO and explained exactly what I wanted made. Many e-mails passed between the two of us, until we finally came up with a design and weight that I was happy with. The design was approved in March 2009. I explained that I wanted to use the new card guard for my next tournament in Vegas in June 2009. Matt assured me, that he could meet my deadline and at worst, the Skullman card guard would be awaiting me upon my arrival at my hotel. True to Matt's assurance, it was there, ready and waiting. The new Skullman card guard, became an instant talking point while playing in tournaments. Both the players and the dealers during 'table talk' would quickly ask about Skullman. Which then lead into other card guards that players had been given, but had never graced a poker table surface. Thus, the story of how I became known as Skullman on the Poker Circuit.

The WSOP, has also issued card guards for some of their circuit events, which are held at different venues around the U.S. Different Harrah's Casinos, where many of the earlier WSOP events are held, have them for purchase.

## How My Collection Has Evolved

Over time I have collected guards from several sources, through purchase, trades, and as promos. Friends and contacts from tournaments, have been a great source for me. The CC&GTCC conventions and Chip Board has also been good to me. Most poker tournaments have a sales floor to purchase guards either for cash or for poker points.

As I have played in tournaments, I have received card guards as a player. If you have played in WSOP Events at the Rio, Las Vegas, you would have seen card guards on sale in the foyer. The Rio had a number of booths selling a variety of other poker related items. The WSOP mass produce some of their card guards, while some of their issues are very limited and individually numbered. I have been fortunate enough to have obtained two WSOP card guards, and dealer buttons numbered 1. I consider these to be amongst the most valuable ones that I have in my collection. With so few were issued, makes them very scarce and collectible.











In some instances, prototype card guards were manufactured for a poker sponsor or poker room, but never went into production. I have been fortunate enough to obtain two sets from The Palms, which were never issued.



The Venetian and The Wynn / Encore Casinos, issue card guards for their 'bigger' tournaments. Guards can be purchased with Player Points, which are earned by players from the value of the tournament that they participate in.









The majority of officially issued card guards are for sponsored tournaments. There are privately run tournaments, that also issue their own card quards. One example, is the Whiner Invitational Poker Tournament organised by Mr. Steve Bedo (see CCN Winter 2016-17 29-4.) Steve hosted its first tournament in 2007 and is now an annual event held in Las Vegas during the CCGT&CC convention. Each year, Steve has produced a new design and in some instances a new shape, for the tournament's card quards.

















Takeitdownpoker.com produce tournament bespoke card guards. The majority of what they manufacture, are two casino chips glued together, with the buyer's requested logo printed on both the face and reverse sides. Many poker tournament card guards are available only to the final table players only. Sponsors also produce a range of card guards, to be sold to spectators and collectors to commemorate the tournament.

The ARG (alt. Rec. Gambling) community has annual gathering of poker enthusiasts, ATLARGE (ATLantic City Alt.Rec. Gambling Excursion) and BARGE (Big A ugust Rec. Gambling Excursion). Both operators produce card guards for their annual tournaments. World Tavern Poker is another operator that has regularly produced card guards for their various tournaments.

Over the years, Grosvenor Casinos (England, Scotland & Wales), have produced the widest range of card guards that I have seen to date, for their individual casino poker rooms. They have given out their card quards to players in a variety of ways. Very ingeniously, Grosvenor produced one range of card guards, for their seven day Poker Festival at a nominated casino. The guards are in seven different colours, each colour representing a day of the week. They were awarded to the winner of each daily tournament.

Grosvenor Casinos, have also produced card guards for their various National Tournaments like the 25/25 Series (Scotland only), GukPT (Grosvenor U.K. Poker Tour) and The Goliath held at Grosvenor Casino in Coventry (Ricoh Arena.) The Grosvenor Victoria Casino London (The Vic) is one of the longest established casinos in the country and commemorated its 50th Anniversary in 2014 by issuing a poker room card guard.



### **CC&GTCC Claims Form**

Up until now, there has never been a uniform, standardized way of filing a Claim against another member for an alleged Code of Ethics violation. Claims have been filed over the years in formats ranging from hand written notes, typed 5-6 page letters to just an email saying "I want to file a claim against \_\_\_\_\_.".

Most of the time the information provided to the Club is vague and/or incomplete. The Claims Director may spend more time gathering basic information that should have been provided in the first place, than on resolving the issue at hand.

This form provides all the basic information needed by the Club, in written form, first hand from the member filing the complaint.

The process will work as follows:

- 1. Fill out the form completely, sign and date it.
- 2. Forward it the Vice-President..
- 3. Vice-President will make an initial determination on the Claim.
- 4. If further action or investigation is warranted, the Vice-President will forward the form to the Claims Director to open
  - a Claims Investigation.
  - 5. The Claims Director will work to mutually resolve the matter between the parties or if that is not possible, make a recommendation to the Board of Directors for the appropriate action.
  - 6. The Board will act on the recommendation and the final report of the Claims Director. The parties involved will be notified of the final decision of the Board by the Vice-President

IF you find it necessary to file a Claim against a fellow Club member, please help us to resolve the matter as quickly as possible by using the Claims Form.




