The nominations for the 2022 CCA Officers and Board of Directors were received and tallied. 19 valid nomination forms were received; one was voided due to late arrival.

The members shown below received a minimum of two nominations from current CCA members, per the requirements, for the CCA Board of Directors' positions shown.

- Vice President: Rich Burgel / Jim Follis
- Treasurer: Frank (Bud) Wisinski [Unopposed]
- Membership Officer: Steve Asrilant / Rich Huber / Mark Lighterman / Roy Nelson

- Messrs. Burgel and Follis both accepted the nomination for Vice President.
- Bud Wisinski accepted the nomination for Treasurer and was unopposed.
- Messrs. Huber, Lighterman and Nelson all declined the nomination for Membership Officer.
- Steve Asrilant accepted the nomination for Membership Officer and was unopposed.

On March 31, 2022, Rich Burgel officially withdrew his candidacy for Vice President. Therefore, Jim Follis was unopposed for the office of Vice President.
