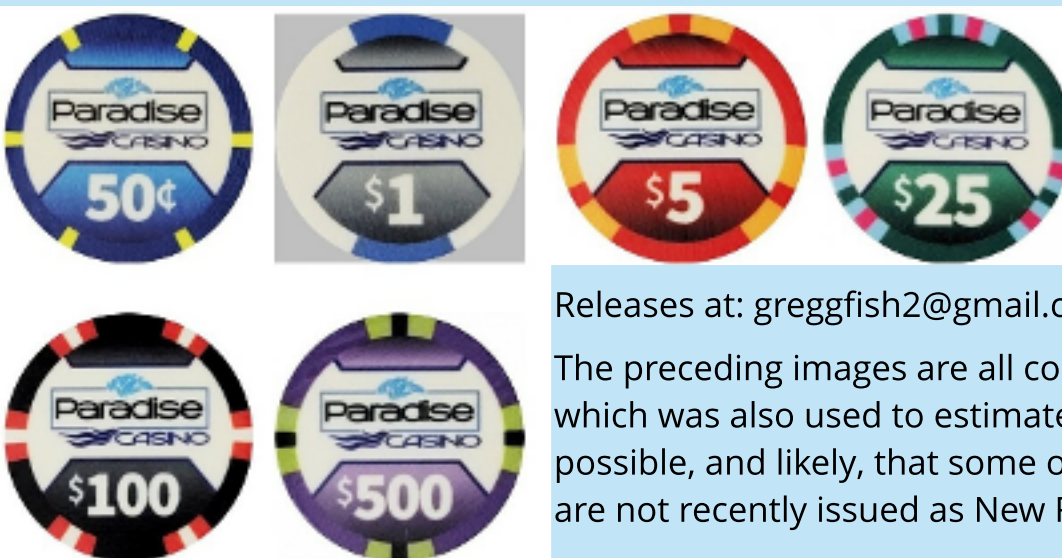

Greetings to all Club Members !!

It is time to start thinking about the 2022 Convention.

Have you thought about having a table and offering to sell some of your overstocks and duplicates ??

Here is your chance to market your items at a reasonable cost.

A dealer contract for the 2022 Convention is posted here and on the club website. Simply fill it out and submit it with your payment and join us for a great time and hopefully a very profitable one as well.

Some General information to answer some common questions

**Location** We will again be using Convention Halls C & D like we did this year at South Point Hotel Casino and Spa located at 9777 S Las Vegas Blvd The Banquet will be held in Hall D also like this year. We will again be allowed to use the large space behind the hall. There will be more activity in that particular space as I am soliciting more vendors and attempting to get Casino Equipment manufacturers to have displays of new and upcoming products. Similar to a mini G2-type show. I have tried this in the past and will continue to pursue this idea.

**Protocol** As of Today, the curtains used in 2021 between the dealers will not be there. Of course, if there is a mandate we will have to comply. This is a very fluid situation. More information will be given out closer to the Convention.

**Spacing** The tables will be spaced 3 ft apart to better facilitate attendees more access to your space.

My thoughts are that the spacing gave the dealers more space in the front of their table to accommodate more customers as well as a better access point to get behind your table. Having that extra space made our Show look a lot

bigger and utilize the massive space better. Please respond to this question by Jan 1, 2022. Majority rules of the respondents.

**Contract** Please, Please, Please **PRINT** clearly all the information on the Contract. I had a hard time with some of the handwriting and I don't want to make any mistakes with the information. The information from the Contract will be entered into a database as the information goes to different Convention Chairs. When completing the contract please make sure the membership numbers are stated as well as the location where you and your helpers are to pick up the registration packets **.All Dealers and Helpers must be CCA members. To verify your Membership numbers and status please contact Roy Nelson at: [rknelson@yahoo.com](mailto:rknelson@yahoo.com).**

**Chairs** You will notice that I have increased the number of chairs for the tables a standard table will now have 3 chairs included in the rental and a corner table will now have 5 chairs. Additional chairs will also be available for the usual \$5. You may set up the chairs anyway you wish either by having one in the back and two in front or vice versa. Your choice. You are welcome to bring your own personal chairs as long as they are placed behind your table and not In front.

**Display Cases** If you are interested in renting our display cases I would ask when you are finished with them you remove any liners you placed there as well as have the keys left with the unit.

**Electricity** You are welcome to contact me with any electrical needs you may have, or you can contact South Point directly. The rates may have changed from this year. You will need to wait for the layout to come out to inform them of your location.

**Dealer Placement** This year's dealer placement was based on the point system used. This system is used with preference to seniority points

determined by the past number of tables rented and the number of times the dealer has been present at past convention. There are 2 deadlines one for the point system to be counted, the contract must be received by January 31 with the payment, please refer to #10 in the contract. Your placement in next year's Convention may not be exactly the same as this year's as some dealers did not attend the Convention Their points may still be high enough to allow them to regain their usual location on the floor. The final deadline referenced on page 5 is April 1, 2022.

**Decorations** I want to show a lot of excitement when the Hall doors open for our Show. I am planning on having balloons and stand-up cutouts on the floor. Anything you can do to make our Show more eye appealing would be great. Our theme is ***Dueces Wild*** which is a play on 2022 the year of our convention. I will donate an engraved Woodford Reserve bourbon bottle to the dealer who promotes their booth the best.

**Advertising** Our Publicity Director Brad Smith will be putting together another great advertising campaign. We are looking at possible TV spots as well as the Radio Spots and the Live radio feed in the Convention Hall like this year.

I hope you will join us again for our next year's great Show.

## CC&GTCC, INC. DBA Casino Collectibles Association (CCA) DEALER TABLE APPLICATION

29TH ANNUAL CONVENTION AND SHOW EXHIBIT HALL C, SOUTH POINT HOTEL & CASINO,  
LAS VEGAS, NEVADA JUNE 15, 2022 (DEALER SET-UP) - SHOW DATES JUNE 16 - 18, 2022

Please reserve a dealer table(s) for my use at the 2022 CCA Convention. I understand that the dealer tables are offered by invitation only to CCA members in good standing.

A STANDARD table includes one (1) eight-foot table with one back up table, dealer sign, three (3) chairs and two (2) dealer badges, four (4) tablecloths

A CORNER table will include two (2) eight-foot tables with one (1) back up table, dealer sign, and five (5) chairs and three (3) dealer badges, six (6) tablecloths

***The tablecloths provided to your tables are the property of the CCA, in order to eliminate additional costs please do not remove the tablecloths from the Convention Hall.  
This would be greatly appreciated.***

\*\*\*\*\* ALL DEALERS AND TABLE HELPERS MUST BE CCA MEMBERS \*\*\*\*\*

### CONTRACT PROVISIONS

- 1) The dealer table assigned to each member cannot be sold, rented, loaned or leased by any other individual during the convention without the approval of the Convention Chairman.
- 2) The cancellation of the rental agreement or failure to appear for the CCA Convention will result in the loss of all payments.
- 3) Although the South Point Hotel does not offer electrical service to the individual dealer tables, they have an arrangement with an electrical contractor to do all of the Convention power supply. Information will be in the future dealer packet. You will need to contact the vendor directly if you need electrical service.

***Please plan accordingly.***

- 4) Dealers are allowed to sell **ONLY CASINO RELATED COLLECTIBLE MATERIALS** or **COINS** unless pre-approved otherwise, by the Chairman.

5) **NON-GENUINE** items are expressly prohibited, unless such **articles** are clearly and plainly marked as "**reproductions**", "**copies**", "**fakes**", "**repaired**" or "**fantasy**" items.

7) It is understood that the CCA does not provide insurance against any damage or loss suffered by fire, theft, accident or personal injury and the signor of this contract further agrees to indemnify and hold harmless the CCA, its officers, agents, volunteers, and participants against any and all such claims by the signor and on behalf of any and all co-workers, helpers, assistants, and anyone else with a dealer badge from the signor's table or working behind the dealer's table.

8) Table priority for the 2022 Convention will be given to previous table holders in good standing, and then to new applicants based on date received. If, in the future, the space available is insufficient to meet table demand, table priority will be determined as follows: First priority goes to table holders from the previous Convention and then to past table holders from prior conventions.

9) All dealers are required to keep their table(s) open, and wares displayed for the **FULL HOURS OF THE SHOW**. There will be no breaking down table space early. Any dealer who violates this provision may be banned from future Conventions or face other sanctions.

10) If a prior year dealer does not submit an application by the deadline (With a postmark date of no later than January 31, 2022), the dealer will not have priority based on points, but will get priority based on date of submission after the deadline, along with all other "after the deadline" submissions. This means that a prior year dealer will not be assigned as good of a location as if the prior year dealer had submitted the application within the allowed deadline.

11) The Convention Chair(s) reserve the right to expel any dealer or individual who conducts himself or herself in a manner deemed unbecoming to our organization, or who violates any provision of this agreement, or who violates the CCA Code of Ethics. In such event, there will be no refund of table fees.

12) Any dealer allowing someone else to use his or her badge will have the badge revoked for the duration of the Convention and may be denied table space at future Conventions.

13) Pre-registration packets are NOT included with Dealer Contracts. Dealers and table helpers will need to order their own pre-Registration packet, if desired, by submitting the proper form and payment. Dealer and helper badges include show admission fee.

14) NEVADA DEPT. of TAXATION: We are required to provide a list of all Dealers at our Show. At the Show, you will receive a Nevada State Dept. of Taxation form that you will be required to fill out and return to the CCA Treasurer (Bud Wisinski) by the end of the Show. If you do not fill out and return the form, you will be in violation of the Nevada State Dept. of Taxation and may not be allowed to take part in future shows in Nevada.

## Becoming a CCA Life Member

Roy Nelson, CCA Membership Officer...

Any Club member interested in becoming a Life Member, should note the following qualifications as excerpted from the Club's Constitution:

E. Life Members: members in good standing **age 25 or older** who apply, after completion of their third full year of membership for permanent membership status, and whose applications are accompanied by payment, according to the following schedule. Life Members are relieved from paying further annual dues, but must pay any magazine mailing charges above bulk mail, if the Life Member desires such mailing enhancement:

Age 25-39: then-current dues times 25

Age 40-55: then-current dues times 20

Age 55+: then-current dues times 15

After 10 years of continuous completed membership the following rates would apply:

Age 56-75: then-current dues times 10

Age 76+: then-current dues times 5;

E (i). Dues Changes Impacting Life Members: if the Board of Directors raises the organization's annual general membership dues, thus impacting the Life Membership cost to someone who at that time has been a member for less than three years, the Board of Directors may, in its discretion, grandfather in all those members who have been members for less than three (3) years, so that those members, once they have completed their third year, may become life members by paying the multiplier times the annual dues in effect when they first became a regular member. The member must pay the increased annual dues until the completion of the third year. At the completion of the third year, the member has a one-time only, two month window to apply for Life Membership at the grandfathered lower rate.

### CCA TO MEET AT ANA CONVENTION IN COLORADO SPRINGS

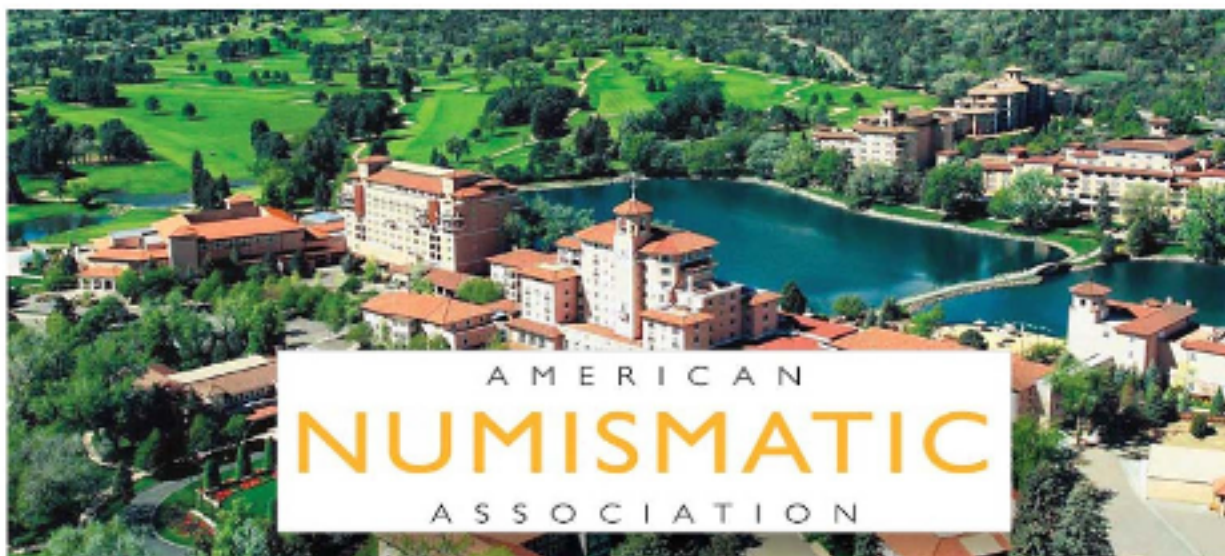

### NEW OUTDOOR MURAL HIGHLIGHTING SOUTHERN NEVADA IN THE 1940s

Made possible by a grant from Nevada Humanities, Mob Museum Advisory Council Member and artist Miguel Hernandez painted a beautiful depiction of Southern Nevada in the 1940s. Throughout this period in Las Vegas history, the city experienced the arrival and growth of the Las Vegas Army Airfield and the Basic Magnesium plant in Henderson, Nevada. The city also underwent major casino development Downtown, including the addition of the El Cortez Hotel & Casino and Golden Nugget Las Vegas which are depicted in the mural.

El Rancho Vegas, Hotel Last Frontier and Flamingo Las Vegas, known as Highway 91 at the time, are also incorporated into the artwork.

The mural, available for viewing now, is the first segment of a larger mural.

The continuation of the artwork will commence in the coming weeks showcasing Las Vegas predating the 1940s.

Miguel Hernandez is a Las Vegas based artist, originally from Los Angeles. Hernandez began his artistic career as the Zappos resident artist. His artwork has brought him across several states and can be found at the Zappos campus, local businesses, schools, music festivals and various charity events. On May 16, 2016, Mayor Carolyn Goodman dedicated the date as "Miguel Hernandez Day" after Hernandez unveiled a vintage car mural at The Mob Museum.
