On the Docket... Board Actions Through November 2023

Membership Dues Increase - A reminder - In June, 2023, the CCA Board discussed and proposed Dues increases of \$5 for Regular Memberships and an increase of \$2 for Associate memberships, beginning in January 2024. This increase is only the 2nd increase in 18 years.

Action: January 1st, 2024, these dues increases will be implemented, bringing Regular annual membership to \$40 and Associate annual memberships to \$7.

MoGH Changes: The CCA Board has accepted a Final Report of the Special Committee to Review the organizational structure and mission of the MoGH. Moreover, the MoGH Board has responded to the recommended changes, and has submitted a response to the CCA Board, which has been approved for implementation.

Action: Details will be disseminated soon after distribution of this Newsletter, as a Special Edition.

Appointment of a Temporary Election Chair: CCA President, David Spragg has appointed, on an interim/temporary basis, Former CCA President, Doug Smith as the 2024 Election Chairman. The CCA Board continues to solicit a CCA volunteer to take on the duties of the CCA Election Chair. Any CCA member, in good standing, interested in this important position is asked to contact any CCA Board member, or Doug Smith for information about this position, or to volunteer for appointment into this role.

Action: The 2024 Elections process is now in effect. The Candidate Nomination(s) form is included elsewhere in this Newsletter, as well as online at the CCA's website, and in the Winter issue of the Casino Collectibles News.

1/2 Price Dealer Table BONUS for Last Year Dealers: Based on a suggestion from a CCA Member, to Convention Chairman and passed to the CCA Board, it was decided to provide a 1/2 price table (1 table only), to the Dealers of Record from last years' Convention. This means more offerings and a bigger foot print on the Convention Floor.

Linked HERE is a Dealer Contract for the June 2024 Convention.

GOOD NEWS - no increase in table fees or admission fees for 2024...

GOOD NEWS #2 – for 2024 we are offering the opportunity for any dealer who had tables for the 2023 show to purchase one additional table for the discounted rate of \$140.00.

Here is the fine print conditions:

The bonus table is available as an additional table above the number of tables you had in 2023. Example – if you had two single tables or one corner table you would be able to add one single bonus table. If you had one single table, you could add one bonus table. If you had three single tables, you could add one bonus table. See the pattern? The bonus table is over and above the number of tables you had in 2023. If you had two single tables, you could not sign up for one regular price table and a bonus table. Only one bonus table available per dealer.

By adding additional tables to the show floor, table positions from 2023 may change slightly but every effort will be made to honor your placement requests based on the Dealer Point System, 2023 floor plan and final table floor plan.

Please read your contract and abide by the content. Load-in and set-up instructions will be sent to each dealer advising the date, time, and hours of access to show floor.

I will send confirmation of receipt of your contract. Based on postal service please allow two weeks after mailing your contract and check. If you have not received confirmation by then contact me at: Convention@ccgtcc.com, or jimsteffner@mail.com.

CCA NEWS and ACTIVITIES

Website Redesign - The CCA website is now fully operational. Thanks-a-plenty are due to Barry Sherwood, Mike Brodeur and David Spragg.

The new website includes a new Message Board, referred to as a "Forum". The old Message Board (thank you Greg Susong) has now been archived, into 2 segments, and is still accessible, as a read-only, searchable listing of all past messages.

2024 Convention Theme: In other news regarding the 2024 Convention, member suggestions for a theme were reviewed by the Convention Chairman and the CCA Board. Submitted suggestions included Halloween branding because the Convention will be #31, a number associated to Halloween. Triskaidekaphobia branding, again a take off of "31" and it's mirror image, "13". A "31" flavors theme was presented. Lastly, several suggestions were made to theme the Convention in conjunction with the year, "1931" when gaming was legalized in Nevada. It has also been noted that the typical first 3 denominations of gaming chips (\$1, \$5 and \$25), when added together, equal "31".

Accordingly, the theme for our 31st Convention will be based on that 1931 date and activities relating to gaming in that year.

WANTED Convention Chairman 2025 (and beyond?): Do you think you have what it takes to be the CCA's Convention Chairman in 2025? As with any CCA Committee, the CCA President, in consultation with the CCA Board, will make the appointment.

RIP John K. Kallman, 1951 - 2023

John was one of the most active ChipGuide Administrators, where his responsibilities included: New Zealand, Australia, North Dakota Charity Casinos, Minnesota, Military, Asian Poker Rooms and Nevada Route Tokens. He processed tens of thousands of user submissions into ChipGuide. As a collector, John contributed images of over 10,000 items from his collection to the ChipGuide. For his service to ChipGuide, he was awarded the Museum of Gaming History's Chairman's Award in 2022. John was a long-time Life Member of the CCA (LM 0112-112), a Convention Dealer and he was the CCA's Librarian from 2007 to 2016. John was an all-around great guy and a friend to everyone he met. He will be sorely missed.


offered at the 31st Convention and also via mail order to the MoGH's Promotions Director, Pam Focazio, at: pam@themogh.org.

MoGH Donations - The MoGH has received several donations recently, as follows:

1. In November we received an unsolicited donation in a most circuitous manner. While visiting with the GM of the El Cortez, Mr. Adam Weisberg, for a new El Cortez Exhibit (more on that later) he handed me a USPS Priority Mail bubble envelope, that was address to the MoGH, in care of the El Cortez. 
We thank Mr. David Poplawski for his unsolicited donation to the MoGH.

2. The MoGH also received a contact from the family of a collector that had passed away, and was asking what they could do with his sizable collection of plastic, casino coin cups. The MoGH reached out to his family advising that there is not much of an interest in plastic casino coin cups/buckets, as opposed to paper coin cups, however, the MoGH would be interested in receiving the collection to make photo contribitions to ChipGuide of all the cups, and denote the deceased collector as the contributor. The MoGH has now received that collection and will be developing a methodology to photograph and insert those images into

ChipGuide under the name of: David I. Kopp.



3. Charles Kaplan, MoGH Chairman advises that several months ago he was contacted by an author, looking to use images from ChipGuide in a book he was authoring. The author, Jason Alan Elwell and Charles made





an agreement that he could use the images, giving credit to the MoGH's ChipGuide and donating a copy of the book, "Numismatics of the Borderlands" to the CCA's Lending Library.

"Trail of the MoGH" Exhibits Update - The Jackie Gaughan Tribute

As noted above, as the Director of Exhibits and Events I had a meeting with the GM of the El Cortez, where the MoGH's "Jackie Gaughan Tribute" Exhibit is housed. Mr. Weisberg, through a prior meeting with Charles Kaplan had offered an additional location within the El Cortez for the MoGH to display more El Cortez artifacts.

Inside the El Cortez there is a hallway that connects the coin-operated slot machine area and the main casino area, as breezeway between the two sides of the building. That hallway is named the "Hallway of History" and is used to hang historic, large sized, framed Las Vegas News Bureau photographs. Towards the West end of the hallway is a no longer used service window, previously used as a pass-through from the hall to the security office. This service window has since been blocked off (on the security office side) leaving an opening of about 38" (h) x 36" (w) x 3" (d), with a lockable, clear glass, sliding window on the hallway side that Mr. Weisberg would like filled with casino collectibles. He has already placed a salvaged section of the old El Cortez carpet on the back wall.

The MoGH has temporarily placed several collectibles at this location, but will be return to finalize the Exhit and do a refresh of the Jackie Gaughan Tribute Exhibit.

Several months ago I was contacted by Mr. Michael Morris, a CCA member, advising that he specialized in collecting El Cortez memorabilia and that he wished to loan his collection to the MoGH for display at the El Cortez "Jackie Gaughan Tribute" Exhibit. Michael's collection will soon be integrated into the existing exhibit and we thank him for his offer to loan items for the Exhibit. Some of those items are presented below and on the following page.









Once these items are added to the "Jackie Gaughan Tribute" Exhibit, we will make the announcement here.

In another more very recent develoment, I have been contacted by the CEO of the Plaza, Downtown Las Vegas, where the MoGH has another "Trail of the MoGH" Exhibit. This Exhbit is dedicated to the PLAZA, since it's construction in 1971. We have a meeting set for early January, and once that is completed, we will have more info to pass along.

"Trail of the MoGH" Locations on Google Map's, My Maps - The CCA website Team is currently working on a feature to appear on the MoGH's website, that interactively shows the "Trail of the MoGH" locations on a Google Map interface, and will also provide directions on how to get to the Exhibits within their respective locations. Silver Strikers News - Four Queens Tournament and \$300 Strike Release Dates 2024.



January Tournament 26, 27, 28, 2024

\$300 handed out, Saturday January 27th at 5pm.

St. Patrick's Day 2024 – \$300 handed out Friday March 15th at 10am.

June Tournament 21, 22, 23, 2024 \$300 handed out, Saturday June 22th at 5pm.

Halloween 2024 – \$300 handed out Friday October 25th at 10am.

The blue, red and yellow (\$40 machine) capsule strikes are normally in the machines the Wednesday before the \$300 release date.
