Attached is a dealer contract for the June 2026 convention.

Convention theme for 2026 will be AMERICA'S 250th BIRTHDAY

GOOD NEWS – no increase in table fees or admission fees for 2026.

GOOD NEWS #2 – for 2026 we are again offering the opportunity for any dealer who had tables for the 2025 show to purchase one additional table for the discounted rate of \$140.00.

Here is the fine print conditions.

The bonus table is available as an additional table above the number of tables you had in 2025. Example – if you had two single tables or one corner table you would be able to add one single bonus table. If you had one single table, you could add one bonus table. If you had three single tables you could add one bonus table. See the pattern? The bonus table is up and above the number of tables you had in 2025. If you had two single tables you could not sign up for one regular price table and a bonus table. Only one bonus table available per dealer.

By adding additional tables to the show floor table positions from 2026 may change slightly but every effort will be made to honor your placement requests based on the dealer point system, 2025 floor plan and final 2026 table floor plan.

Please read your contract and abide by the content. Load-in and set-up instructions will be sent to each dealer advising date, time, and hours of access to show floor as show time gets closer.

I will send a confirmation of receipt of your contract. Based on postal service please allow two weeks after mailing your contract and check. If you have not received a confirmation by then contact me.

Greeting to all convention dealers. Here is a summary of useful information before the show begins.

Location: For those who have not attended a convention before – the show is in Exhibit Hall D of the convention center situated on the way from the Binion statue to the Arena. There will be signage on the casino floor. Proceed up the escalator and then take a sharp right turn to the registration desk. There is an elevator at the bottom of the escalator also. For those arriving through the rear loading bay, proceed to Level 2 of the garage and head for the furthest left corner. Please note the garage has an 8 foot height clearance.

Set Up: You may commence setup as soon as you have your badge (in your registration package). Set up hours are 9am – 4pm Wednesday and 7am – 9am Thursday. Badges are available at registration desk or at rear of show floor depending on where you indicated your pickup location.

Registration: You have all indicated where you and your helpers will be picking up your registration packets. Either at the Back door or the Front Registration Desk. Please stay with the area you indicated. If you go to the wrong entrance you will have to wait for a runner to get you your packets. No one will be allowed to enter or walk through the hall on Wed without a badge.

Linen: Some of the table linen used belongs to the club. Each table (front and back) will have either a black, blue or red tablecloth that drapes all the way to the floor. You will also be given blue tablecloths to drape over each table overnight.

•Please note that the blue and red covers are the property of the club and the black covers belong to South Point. It would be appreciated that none be taken. In the past when we rented from South Point a number did go missing which we had to pay for.

Chairs: All our chairs are now rented from an external source. You have been allocated the number of chairs specified in the contract plus any additional that you paid for. We are not allowed to use ANY South Point Chairs and it will become evident if chairs are removed from any other area. In the event you did not order enough, your options are you can contact me at the convention to see if there are any extras at \$5 or you can bring your own personal chairs.

Concession Stand : A concession stand is located outside the show floor going toward the arena.

Security: There will be a security guard in the hall overnight for your protection. However I would advise you to take any highly valued items with you and not leave them at your table.

Break Down: The show ends at 4pm on Saturday. You are requested to vacate the hall as soon as possible, ideally by 5pm, so the teardown crew can start.

Dealer table assigned locations. All requests for specific location will be honored as close as possible. Dealers are normally assigned spaces based on seniority, last years attendance and point standings. If you have any specific requests make note on your contract form.

BONUS TABLE: As in past years we are offering a bonus table at a reduced price. If you had a table at the 2025 show then you may order one extra bonus table at \$140.00. Only one table per dealer.

A STANDARD table includes one (1) eight-foot table with one back up table, dealer sign, three (3) chairs and two (2) dealer badges, four (4) tablecloths

A CORNER table will include two (2) eight-foot tables with one (1) back up table, dealer sign, and five (5) chairs and three (3) dealer badges, six (tablecloths)

***The tablecloths provided to your tables are the property of the CCA, In order to eliminate additional costs please do not remove the tablecloths from the Convention Hall.
This would be greatly appreciated.***

******* ALL DEALERS AND TABLE HELPERS MUST BE CCA MEMBERS *******

CONTRACT PROVISIONS

- 1) The dealer table assigned to each member cannot be sold, rented, loaned or leased by any other individual during the convention without the approval of the Convention Chairman.**
- 2) The cancellation of the rental agreement or failure to appear for the CCA Convention will result in the loss of all payments.**
- 3) Although the South Point Hotel does not offer electrical service to the individual dealer tables, they have an arrangement with an electrical contractor to do all of the Convention power supply. Information will be in the future dealer packet. You will need to contact the vendor directly if you need electrical service.**

Please plan accordingly.

- 4) Dealers are allowed to sell ONLY CASINO RELATED COLLECTIBLE MATERIALS or COINS unless pre-approved otherwise, by the Chairman.**

5) NON-GENUINE items are expressly prohibited, unless such articles are clearly and plainly marked as "reproductions", "copies", "fakes", "repaired" or "fantasy" items.

7) It is understood that the CCA does not provide insurance against any damage or loss suffered by fire, theft, accident or personal injury and the signor of this contract further agrees to indemnify and hold harmless the CCA, its officers, agents, volunteers, and participants against any and all such claims by the signor and on behalf of any and all co-workers, helpers, assistants, and anyone else with a dealer badge from the signor's table or working behind the dealer's table.

8) Table priority for the 2026 Convention will be given to previous table holders in good standing, and then to new applicants based on date received. If, in the future, the space available is insufficient to meet table demand, table priority will be determined as follows: First priority goes to table holders from the previous Convention and then to past table holders from prior conventions.

9) All dealers are required to keep their table(s) open, and wares displayed for the FULL HOURS OF THE SHOW. There will be no breaking down table space early. Any dealer who violates this provision may be banned from future Conventions or face other sanctions.

10) If a prior year dealer does not submit an application by the deadline (With a postmark date of no later than January 31, 2026), the dealer will not have priority based on points, but will get priority based on date of submission after the deadline, along with all other "after the deadline" submissions. This means that a prior year dealer will not be assigned as good of a location as if the prior year dealer had submitted the application within the allowed deadline.

11) The Convention Chair(s) reserve the right to expel any dealer or individual who conducts himself or herself in a manner deemed unbecoming to our organization, or who violates any provision of this agreement, or who violates the CCA Code of Ethics. In such event, there will be no refund of table fees.

12) Any dealer allowing someone else to use his or her badge will have the badge revoked for the duration of the Convention and may be denied table space at future Conventions.

13) Pre-registration packets are NOT included with Dealer Contracts. Dealers and table helpers will need to order their own Pre-Registration packet, if desired, by submitting the proper form and payment. Dealer and helper badges include show admission fee.

14) NEVADA DEPT. of TAXATION: We are required to provide a list of all Dealers at our Show. At the Show, you will receive a Nevada State Dept. of Taxation form that you will be required to fill out and return to the CCA Treasurer (Bud Wisinski) by the end of the Show. If you do not fill out and return the form, you will be in violation of the Nevada State Dept. of Taxation and may not be allowed to take part in future shows in Nevada.
